Tournament costs are \$150 per team per event. A late fee of \$50 is charged if signing up after 8 PM the Sunday prior to the tournament. Membership in the WBSA is a requirement and is \$20 per year per person and includes full use and access to all club functions and website/message board and newsletters. No checks are accepted within 6 days of the tourney.
